Partnership with MCGM Schools

Aseema's partnership with the Municipal Corporation of Greater Mumbai (MCGM) went one step further with the passing of the new Public Private Partnership Policy. The Aseema team, along with other organizations, had worked closely with MCGM officials to develop this policy. Through this policy, organizations with expertise in the field of education would be able to contribute more effectively to the running of municipal schools.

A Steering Committee has been set up by the MCGM to ensure credibility of partner organizations and oversee implementation. Aseema's Chairperson has been invited to be a part of this Steering Committee and participate in the selection and evaluation process.

While this will undoubtedly impact the larger picture of public education in Mumbai, our focus has continued to be on creating centres of excellence in municipal schools run by Aseema. Our work at the Pali Chimbai Municipal School, the Santacruz (W) Municipal School and the Kherwadi Municipal School has grown over the past year to reach out to more children and engage in more meaningful activities.

Pali Chimbai Municipal School

The Pali Chimbai Municipal School adopted by Aseema in 2001 is a small school with a large number of children and a lot of character. As you enter the school, you are often greeted by the sounds of a lively sports class being conducted in the playground. On walking a little further, you may spot a group of children working busily on tablet computers and others studying African art forms or reading quietly. It is hard to believe that some years ago, this school was on the verge of shutting down. With dilapidated infrastructure and dwindling enrolments, the Pali Chimbai Municipal School was very different from the one we see today.

Today, the school is as well equipped as any other and has enrolments to full capacity. In the year 2013-14, 579 children were enrolled in Standards I-VII and the average attendance was 82 percent. The children spent a year focused on building academic skills — particularly language skills — and engaged in various co-curricular activities. Our teachers conducted extra classes after school hours and sought the help of volunteers to give children more individual attention.

As you enter the school, you are often greeted by the sounds of a lively sports class being conducted in the playground.

A special three-month remedial programme was conducted for children with academic lags. The children worked hard on their reading, writing and comprehension skills. At the end of the programme, they wrote the most imaginative short stories and had them *published* in a book. This experience encouraged them greatly and it was a pleasure to see even the most reticent child read his own story in front of an audience.

Sports classes were introduced on a daily basis this year. The theme chosen for the year was 'agility' and all children were expected to participate in one hour of Sports every day. Music classes, conducted in collaboration with the Mehli Mehta Music Foundation, were extremely popular. The highlight of these classes was when the children witnessed a live performance by acclaimed musician, Nicole Benedetti and members of the Royal Conservatoire of Scotland. Our little ones watched them in complete awe as notes of the cello and violin filled the school.

Our donors and well wishers added much cheer to the school by organizing special celebrations, football coaching camps, art activities and judo displays. The year ended with much excitement over the release of the movie *Hawaa Hawaai* directed by Mr. Amole Gupte. Mr. Gupte has been conducting Cinema and Theatre classes in the school for the past seven years and chose four of our students to play key roles in the movie. Under his guidance, the children have grown in confidence and their families and all of us were delighted to see their performances.





Santacruz (W) Municipal School

The Santacruz (W) Municipal School is one of the few municipal schools in the area offering Secondary education in the English medium. It has grown over the years to be regularly sought out by children from the suburbs of Bandra, Khar and Santacruz. This year, due to the growing demand for enrolment, a third batch of Standard VIII was started in the school. A total of 174 children were enrolled in Standards VIII–X and the average attendance was 77 percent.

The curriculum in the Secondary Section is well structured and quite intensive. The children are preparing for the SSC Board Examination which has a vast syllabus. At Aseema, we do, however, lay great emphasis on co-curricular activities and holistic education. In addition to the academic subjects, the children participate in regular classes for Art, Sports, Computers, Personality Development and Social Service. This year, they won the first prize at an Inter School Drama Competition and several gold and silver medals at district level Judo competitions.

Our fourth batch of Standard X appeared for the SSC Board exam and secured 92 percent results. At the farewell party organized for them in April 2014, the children spoke fondly of their time in the school and demonstrated how they had learnt so much more than academics.

At Aseema, we do, however, lay great emphasis on cocurricular activities and holistic education.

The Pre Primary Section at the Santacruz (W) Municipal School had six Montessori environments for children between 2.5 and 6 years of age. A total of 210 children were enrolled and the average attendance was 85 percent. The children developed skills in English, Mathematics, Sensorial Development, Exercises of Practical Life and Culture by working with the scientifically designed material

in the classroom. Our teachers made an attempt to give them practical experiences while learning different concepts. Planting seeds, going on nature walks, engaging in non-fire cooking experiments and art activities had the children looking forward to school every day.

Along with children of all other Aseema centres, our Pre Primary children too enjoyed a nutritious meal and a banana every day. Children as young as 2.5 years serve themselves with care, gauge how much they would like to eat and happily come back for second helpings. The independence and discipline learnt by the children at this age undoubtedly impacts their learning for life.

At the end of the year, when parents of the children were invited for a graduation party, they were most impressed by their little ones and all that they had blossomed to be.

Kherwadi Municipal School

The Kherwadi Municipal School took a big leap this year with a change in school timings. The children of this school now put in longer hours each day and get seven hours more study time per week than children of other municipal schools. As a result of this, additional classrooms were set up and two parallel schools now run in the same building.

Visits from professionals in the field of business opened their eyes to new career opportunities.

The school had four Montessori environments and classes from Standards I to VII this year. A total of 557 children were enrolled and the average attendance was 81 percent. The children demonstrated insatiable curiosity and were engaged in research and project work throughout the year. Each of the projects stemmed from a question the children brought up in class. Rather than simply leading them to the answer, their teachers encouraged them to delve deeper and find answers for themselves. The questions and topics they chose were diverse — ranging from the life cycle of salmon to how musical instruments are made.

A special project undertaken by the children was on Child Rights. The children conducted a survey on child labour in their community and presented their findings to their peers. As they begin to experience the joys of education, the children are becoming increasingly sensitive to the plight of those less fortunate. Their compassion and drive to make a difference, is heartwarming to see.

A range of field trips, celebrations and events filled the school calendar this year. A visit from noted author Ken Spillman inspired the children to write their own stories. An invitation aboard an aeroplane on the occasion of Children's Day had them aspiring to be pilots and airhostesses. Visits from professionals in the field of business opened their eyes to new career opportunities.

The children represented their school with great pride and earned accolades and appreciation. At an inter NGO Sports tournament they won 9 medals including "Best Girls Team" and "Best Athlete". As a very special treat, one of the girls along with two children from the Pali Chimbai Municipal School was invited to watch an IPL cricket match in Dubai. Her delight was shared by every other child and adult in Aseema.





Support Centre and Alumni Programme

The Support Centre — Aseema's after school programme — completed 16 years of existence. Over the years, many of our children have passed through the Support Centre and taken comfort in the attention and guidance offered to them there.

rainwater harvesting, deforestation and global warming were discussed with much seriousness by our little children.

This year as well, the children attended classes to seek help with academic work and participate in creative learning activities. A new initiative was the celebration of a week dedicated to the conservation of natural resources. Topics such as soil erosion,

The Support Centre continued to be our link with the Aseema alumni and offered them academic and financial support in their pursuit of higher education.

As the number of children Aseema reaches out to grows steadily each year, we are required to reevaluate and redesign our programmes. In order to reach out to more children, the activities of the Support Centre will henceforth be integrated into the school programmes. We look forward to working with larger numbers of children and helping them build skills and values in the years ahead.

Education Centre for Tribal Children

Aseema's Education Centre for Tribal Children comprises of the Aseema Sitabai Kavji Mengal Anganwadi and Aseema Bal Shaikshanik Kendra. Situated in the remote villages of Igatpuri, the Centre is the only source of quality education for children from the village and surrounding hamlets. Children as young as 2.5 years attend regularly and often reach the Centre well before time – waiting excitedly to enter and begin their activities.

In the year 2013-14, 98 children were enrolled in the Pre Primary section and the average attendance was 75 percent. 36 children were enrolled in the Primary section and had an average attendance of 85 percent. The children worked with high quality educational material and learnt through practical demonstrations. They relished the open space available to them and looked forward to the occasional class outdoors. The older children were helped to prepare for the National Institute of Open Schooling (NIOS) examinations. Seven children appeared for Level B examinations and scored excellent results. These examinations are equivalent to Standard V of other schools.

The parents and community were invited to visit the Centre and participate in its activities on several occasions. This helped create greater awareness of Aseema's work and the importance of education amongst people who have never been to school. On Sports Day, a large group of parents turned up to cheer our children as they ran obstacle races and performed drill displays. At the Annual Day function, they listened attentively as the Primary children hosted the event and performed a play on environmental hazards. The children danced and sang with greater gusto as they looked into the audience and saw the proud faces of their parents.

A special occasion in Igatpuri every year is the celebration of Adivasi Diwas or World Indigenous Peoples' Day. On this day, the villagers join our children and staff in celebrating their tribal heritage. Our conscious endeavour on this day and throughout the year is to help the children grow in knowledge and experience while remaining firmly rooted in their own native culture.

Training Centre

Aseema's Training Centre continued to offer support to organizations working in the field of education for marginalized communities. In Kanpur, staff of one school and eleven community centres were offered training in operating child friendly education programmes. In Mumbai, capacity building sessions and on the job support were offered to staff of ICDS Anganwadis in the Bandra East community. Through these training programmes, we reached out to 829 children.

Counselling Centre

Aseema children live in environments that are very challenging and often disturbed. They experience the harsh realities of living in a slum community and grapple with problems far beyond their age. It is often difficult for them to devote themselves to learning when there is so much more on their minds. Our Counselling Centre offers them the time and experience of qualified psychologists who are trained to address their emotional concerns.

This year, 108 children availed of counselling facilities. Individual and group therapy sessions were conducted for them. Referrals were also made for psychiatric consults, speech and audiometric therapy. Relationship education sessions were held to help children become aware of their bodies, understand social aspects of development, develop a sensitive approach to relationships and practice gender equality. Workshops on child sexual abuse were also conducted for students, staff and parents.





A new initiative this year was celebration of an Emotional Awareness week in the month of December. The week was dedicated to promoting a better understanding of emotions and mental health amongst our children, parents and staff. Through role plays, activities and a lot of reflection, our counsellors addressed topics such as labelling, individual differences and self talk. During the sessions, our children came up with remarkable insights into their own thoughts and feelings.

Community Work Centre

Aseema's Community Work Centre has the important responsibility of building a relationship with the families and communities of our children. Through this relationship, the Community Work Centre aims to create a supportive home environment for children's education. The year began with enrolment drives to ensure all our centres enrol children at

the right age and to full capacity. A total of 1864 enrolments were accepted in keeping with the norms of the Right to Education Act. Regular follow up was done for any child who was irregular at school. Through home visits,

personal discussions and interaction with the parents, the Community Work Centre reiterated the importance of regularity and punctuality in school.

Nutrition was given special emphasis in the schools. All children enjoyed a nutritious lunch along with a banana every day. Health of the children was monitored and children at risk of malnourishment were given additional protein supplements. Medical needs of the children were also addressed. Free consultations were available to our children with a reputed doctor in the vicinity. In addition, eye checkups, dental checkups and general health checkups were conducted.

As part of project 'Umeed', our team collaborated with other organizations to celebrate International Day of the Girl Child. This celebration threw light on the discrimination faced by girls and aimed to create sensitivity amongst parents and other stakeholders. Capacity building workshops were held for parents of our children. Topics such as nutrition, de-addiction, child rights and financial literacy were touched upon. The parent representatives who were a part of our "School Management Committee" took an active role in organizing these sessions and also participated in other school events.

Product Division

The Aseema Product Division celebrates the artistic talents of our children by featuring them on high quality products. The striking art work created by our children in their schools inspired a wide range of new products this year. Mini Easels with canvas prints of the paintings were extremely popular. Our new iPad and Laptop Covers featured beautiful paintings inspired by the style of Henri Matisse.

Our best sellers from previous years — the trays, gift hampers, desktop accessories and home decor products continued to earn much appreciation Throughout the year, we participated in 128 exhibitions including the Kala Ghoda Art Festival. We also received 90 corporate orders for gifting during Diwali, Christmas and other festive occasions. The Aseema product range was also available at the Lotus House Airport Shop, Suriti – The Culture Shop, Taj Khazana Goa, Oceane Store – South Carolina, amazon.in, eBay.in and on our website.

Staff Development

We are proud to share that we had four new additions to our esteemed Board of Advisors this year — Ms. Ashu Suyash (CEO, L & T Investment Management), Ms. Bhaswati Mukherjee (Former Ambassador of India to UNESCO and Former Ambassador of India to the Netherlands), Ms. Farida Lambay (Co-founder – Pratham, Former Vice Principal – College of Social Work, Nirmala Niketan) and Dr. Indra Munshi (Former Head of Department, Sociology – University of Mumbai) bring with them a wealth of experience and will guide the Aseema staff in the years ahead.

Training in advanced computer operations helped our team streamline some of its processes.

The Aseema team of staff comprised of 188 members. All of these people were drawn to the organization by their belief in the power of education and their commitment to social equity. Through regular interactions, interactive training programmes and on the job support, this team was helped to enhance its skills.

This year, our in house team of trainers worked with teachers on topics such as activity based learning, curriculum planning, classroom management and the role of a teacher. Language development workshops were conducted on a weekly basis. Training in advanced computer operations helped our team streamline some of its processes.

Three of our teachers were sponsored to complete a one year Diploma in Montessori Education from the Ratan Tata Institute. One of these teachers is a former student and is an inspiration to many of her peers. Another teacher from our rural project was helped to acquire a formal teaching qualification. Our Finance and Administration Coordinator was also assisted in completing a Post Graduate Certificate in Development Management. Each of these staff members have returned to the organization with renewed zeal and fresh ideas.

Our teams were supported in their work by an ever willing group of volunteers. Professionals from various fields, homemakers, former teachers and students offered their time and services in the most selfless manner. Our schools would not be the same without them.





Looking Ahead

This year, our teams spent a lot of time reflecting on where we began and how far we have come. We questioned ourselves repeatedly, debated the efficacy of our programmes and delved deeper into our best practices. Over months of discussion, critique and loads of coffee, the Aseema team redefined its vision for the future.

In the year 2014-15, we will recommit ourselves to this vision and the goals which will lead us there. We promise to hold ourselves accountable to these high standards and do our very best for our children.




